

1. Introduction

These Terms & Conditions ("Terms") govern your participation in the ClimateCandy Contest ("Contest") hosted by Operal AG ("Operal"). By participating in the Contest, you agree to be bound by these Terms. If you do not agree to these Terms, do not participate in the Contest.

2. Eligibility

To be eligible for the Contest, you must:

a) Be at least 13 years of age at the time of entry. If you are under the legal age of majority in your jurisdiction, you must obtain the consent of your parent or legal guardian to participate. b) Have a valid and active ClimateCandy account. c) Comply with all applicable laws and regulations in your jurisdiction.

Operal reserves the right to verify your eligibility at any time during the Contest and may disqualify any participant found to be ineligible.

3. Contest Period

The Contest will run from the start date announced on the ClimateCandy app or Operal's social media channels until the end date specified ("Contest Period"). Operal reserves the right to modify the Contest Period at its sole discretion.

4. How to Participate

To participate in the Contest, you must:

a) Play ClimateCandy during the Contest Period. b) Retire carbon credits through in-game actions. c) Follow any additional guidelines or instructions provided by Operal.

5. Prizes

The prizes for the Contest will be as follows:

a) The top ten participant who retires the most carbon credits during the Contest Period will receive 100 USD worth of carbon credits each. b) Other prizes may be awarded at Operal's sole discretion.

Prizes are non-transferable and cannot be exchanged for cash. Operal reserves the right to substitute a prize with one of equivalent or greater value if the original prize is unavailable for any reason.

6. Winner Selection and Notification

Winners will be determined based on the number of carbon credits retired during the Contest Period in the ClimateCandy game. Operal will notify winners within a reasonable time after the end of the Contest Period via the email address associated with their ClimateCandy account. Winners may be required to provide additional information for verification purposes or to claim their prize.

7. Privacy

By participating in the Contest, you agree that Operal may process your personal data in accordance with its Privacy Policy and for the purposes of administering the Contest.

8. Liability

To the extent permitted by law, Operal will not be liable for any loss, damage, or injury arising from or in connection with your participation in the Contest or the receipt or use of any prize.

9. Governing Law

These Terms shall be governed by the laws of Switzerland, without regard to its conflict of law provisions.

10. General

Operal reserves the right to cancel, suspend, or modify the Contest or these Terms at any time and for any reason, without prior notice. Any changes to the Contest or these Terms will be posted on the ClimateCandy app or Operal's social media channels.

By participating in the Contest, you agree to release and hold harmless Operal, its affiliates, and their respective officers, directors, employees, and agents from any and all liability, claims, or actions arising from or in connection with the Contest or your receipt or use of any prize.

If any provision of these Terms is held to be invalid or unenforceable, the remaining provisions will remain in full force and effect.
